- _ Bites, kicks, abrasions or contusions from horses. _ Being thrown or bucked off by horses. _ Scratches or other injury from stalls or enclosures. _ Scratches or other injury from grooming tools and other equine equipment and tack. _ Allergic reactions to animals, hay, or other allergens. _ Slipping, falling, or otherwise being injured in the barn, in stalls, or on the grounds, which can be slippery, muddy, wet, or contain or present other hazards. _ Tripping in holes or on materials or equipment.

I hereby specifically forever waive and release Jacobs' Ladder Therapeutic Riding Center, Inc. &/or Glenn & Leslie Jacobs, as individuals, and its principals and agents from any liability for injury arising out of the inherent risks from riding, working or participating in a stable environment and/or with horses, as well as from the active negligence of Jacobs' Ladder Therapeutic Riding Center, Inc. &/or Glenn & Leslie Jacobs, as individuals, its principals and agents.
